

- 1) The following posts are sanctioned as per the work load calculated taking into consideration the number of students admitted in the aided faculty working in the college.
- 2) Enrollment in the actual college will be mandatory for the subject of the department mentioned in the proposal submitted by the college for designation and the number of students certified by the university.
- 3) The workload has been calculated taking into consideration the number of students required for grant eligibility.
- 4) Batch (group) of the number of subjects prescribed as per government rules shall be mandatory for practicals.
- 5) Lectures, Demonstrations, Tutorials, Project Work (hours prescribed for project work) will be mandatory as per the norms prescribed by the Government.
- 6) It is mandatory to certify the list of reservation posts by the prescribed authority as per the prevailing reservation policy of the government as per the backlog posts in the college.
- 7) In case of decrease in the number of students in the next academic year or if the work load of the aided department decrease due to other reasons, the sanctioned number of posts will be reduced.
- 8) Actions should be taken as per the provisions of the prevailing government decision regarding the adjustment of staff other than additional teachers. No permission will be given for recruitment without induction of additional employees.
- 9) The posts are sanctioned based on grant eligible workload of the college. For recruitment to sanctioned posts, it is necessary to submit a proposal separately and obtain a no-objection certificate as per the prevailing policy and procedure of the government.
- 10) Recruitment to permissible posts as per the prevailing recruitment policy of the government. Recruitment should not be done without prior permission (without no-damage certificate). If appointments are made without compliance with the prescribed procedure without government permission, if any level of irregularity is found during the appointment, the salary of the staff will be disbursed and the respective management and college will be solely responsible for such appointments.


